PURPOSE

The purpose of this Eligible Property Certification Form is to demonstrate that the property referenced above is an eligible property that meets the definition of a brownfield, as set forth by the Ohio Department of Development (ODOD).

ELIGIBLE PROPERTIES & BROWNFIELD DEFINITION

Pursuant to ODOD, a "brownfield" is defined as an abandoned, idled, or under-used industrial, commercial, or institutional property where expansion or redevelopment is complicated by known or potential releases of hazardous substances or petroleum. Further, the contamination to be remediated is required at the subsurface level, unless remediation is needed to gain access to the subsurface contamination (i.e., building demolition) in order to contain the contaminant (i.e., asbestos abatement). If no known or potential releases of hazardous substances or petroleum are identified by a Phase I property assessment, but a building or structure with documented asbestos is present, the property is eligible to prevent a future release during planned demolition or renovation activities.
